*All quotas are based on the aggregated turnover January 2016 until July 2020.

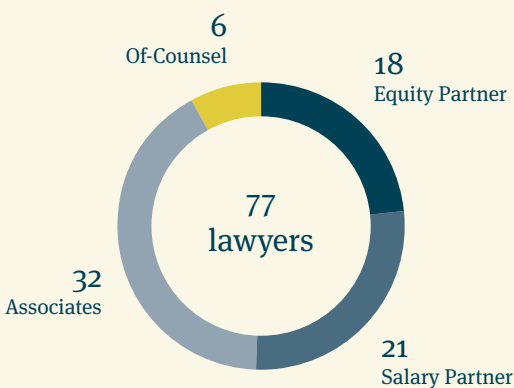

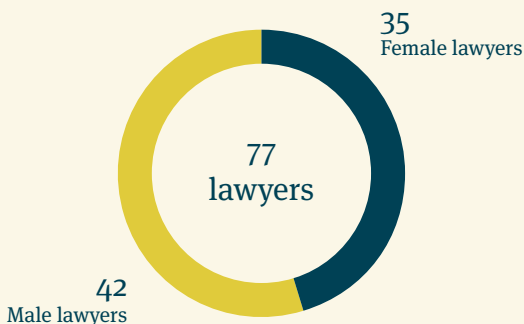
